Mission LiFE is Lifestyle for environment. As per the direction of CPCB, New Delhi, the SPCB-Sikkim conducted awareness activities on theme 'REDUCE WASTE' by oragnising talks at schools, industrial units, healthcare facilities etc., organizing painting competitions in schools, publishing awareness materials like posters, T-shirts with Mission LiFE messages, organizing environmental rallies by school students. The awareness programme has been conducted in primary, junior high, secondary and senior secondary level. The Board has also initiated Awareness programme in various industrial units in the state including Hydro Electric Projects and service industries such as hotels & resorts.

The awareness programme mainly focused on segregation of waste and how wet waste if managed within households. establishments institutions and bv channelizing the waste as local animal feed, composting can exert less pressure on locals bodies and ensure proper disposal of municipal waste. Reduction of use of SUPs other than the 22 banned items was also included in Reuse of old books by the awareness programme. schools itself was also encouraged. The ill effects of uncontrolled consumerism were also highlighted in the programme. Mission Life Logo in Consent, Authorization & correspondence materials were included.

Mission LiFE information was disseminated through SPCB website also. Painting competition was conducted in 20 Government Schools nominated by Education Department.

As per the direction of Hon'ble NGT in the matter of M.A. No. 98/2022 in O.A. No. 180 of 2021 the training on Bio-Medical Waste Management had to be imparted to all the existing District Magistrates and also to Police Academies/Public Prosecutors etc. for compliance w.r.t. the Bio-medical Waste Management Rules, 2016. In this regard, Health and Family Welfare Department, Government of Sikkim in co-ordination with State Pollution Control Board-Sikkim provided training to all the existing District Magistrates, Police Academies/ Public Prosecutors etc. on 30/06/2023 at Chintan Bhawan, Gangtok District wherein EEE, SPCB-Sikkim deliberated on Bio-medical Waste Management Rules, 2016 and other guidelines. He also briefed on current status of Bio-medical Waste Management in the state of Sikkim and penal provision with regard to non-compliance of the Rules.
